

States and Municipalities with Laws Regulating Use of Electronic Smoking Devices (ESDs)

As of July 1, 2025

The following list includes states and municipalities with **laws currently in effect** that regulate where use of electronic smoking devices (ESDs, also known as e-cigarettes) is prohibited. ESDs are battery-powered devices that are designed to mimic cigarettes by vaporizing a nicotine-laced liquid that is inhaled by the user. The use of ESDs in workplaces and public places is a significant public health concern, not only because of their unregulated constituents and the potential health impact of the vapor on users and bystanders, but also because ESD use causes public confusion as to where smoking is allowed, resulting in compliance problems with smokefree laws.

Most local and state smokefree laws were enacted before ESDs were on the market, so while such laws do not explicitly mention ESDs, it should not be assumed that their use is permitted. Existing smokefree laws are often interpreted to prohibit ESD use in their smokefree provisions.

In the 100% Smokefree Venues column, the following abbreviations are used:

W = Non-Hospitality Workplaces **R** = Restaurants
B = Bars **G** = Gambling facilities
