

## Percent of U.S. State Populations Covered by 100% Smokefree Air Laws

## January 1, 2024

This table lists the percent of each state's population covered by 100% smokefree air laws enacted by the state (see *state* rows) and local municipalities (see *local* rows). Only ordinances and laws currently in effect are listed in the table.

**Combo:** Some states include an additional row (see *combo* rows) listing the percent of the state's population covered by the combination of overlapping state and local laws. For example, 100% of Indiana's population is covered by the **state** smokefree non-hospitality workplace and restaurant law while 31.5% of Indiana's population is covered by **local** smokefree bar laws. Thus, while the state law does not qualify as 100% smokefree for bars, in practice 31.5% of the state population has coverage in all three categories due to the overlap of local laws and the state law.

**Note:** Only municipalities and states with ordinances or laws that do not allow smoking in attached bars or separately ventilated rooms and do not allow exemptions based on size, hours of operation, or age of admittance are listed here.

- American Samoa, a U.S. territory, enacted a 100% smokefree restaurant law, which went into effect on 1/19/2011.
- **Commonwealth of Northern Mariana Islands,** a U.S. Commonwealth, enacted a 100% smokefree law for all non-hospitality workplaces, which went into effect on 9/29/2009. E-cigarette use is prohibited in all smokefree venues as of 2/11/2016.
- Guam, a U.S. territory, enacted a 100% smokefree law for all restaurants and bars, which is went into effect on 1/1/2017.
- Puerto Rico, a U.S. Commonwealth, enacted a 100% smokefree law for all workplaces, restaurants, bars and casinos, which went into effect on 3/2/2007.
- U.S. Virgin Islands, a U.S. territory, enacted a 100% smokefree law for all workplaces, restaurants, bars and gaming, which went into effect on 2/1/2011.
- Alaska's 2018 law does not does qualify for ANR Foundation's 100% smokefree non-hospitality workplaces, restaurants, and bars classification, due to a provision in the law allowing local jurisdictions to opt-out of the state's 100% coverage.

Altogether, there are 22,744 municipalities covered by either local, state, or commonwealth 100% smokefree laws in at least one of the three main categories (non-hospitality, workplaces, restaurants, and bars). Since some have 100% smokefree coverage in more than one category, <u>the numbers are not mutually exclusive</u>. Due to the possibility of overlap, it can be confusing to understand what each of the figures on our lists mean. *Please give us a call if you need help determining the population with a particular type of 100% provision, or a particular combination of 100% provisions.*
