The following sample clauses may be helpful if you should choose to make a bequest.

General Bequest:

"I give and bequeath the amount of \$___ to Americans for Nonsmokers' Rights, located at 2530 San Pablo Avenue, Suite J, Berkeley, CA, 94702."

Percentage Bequest:

"I give and bequeath ___ % of the total value of my estate to Americans for Nonsmokers' Rights, located at 2530 San Pablo Avenue, Suite J, Berkeley, CA, 94702."

Bequest of a Residue:

"The rest, residue and remainder of my estate, both real and personal, wherever situated, I give and bequeath to Americans for Nonsmokers' Rights, located at 2530 San Pablo Avenue, Suite J, Berkeley, CA, 94702, to be used as the Board of Directors directs."
