U.S. Tobacco Control Laws Database©: In 2021, the number of municipality records in the database increased to close to 5,930. There are close to 18,727 laws in total in the database. Staff analyzed or reanalyzed 427 laws during 2022 that either increased the number of municipalities with tobacco control coverage or amended existing coverage.

Smokefree Multi-unit Housing: At least 622 communities have smokefree policies\* for Publicly-Owned Multi-Unit Housing. 77 cities and counties have enacted municipal laws that prohibit smoking in 100% of private units of rental multi-unit housing, and the laws in 70 of those communities prohibit smoking in 100% of private units of owner-occupied multi-unit housing. An additional 20 cities and counties have enacted municipal laws that restrict smoking in private units of some types of multi-unit housing buildings.
