Library Tobacco Database: Information Specialists collected and cataloged

451 new documents for inclusion in the organization's library, and **updated** 505 existing documents' records to reflect evolving concepts and developments in tobacco control.

U.S. Tobacco Control Laws Database[®]

In 2023, staff analyzed 708 new laws and reanalyzed many more existing laws, which increased the number of municipalities with tobacco control coverage, and amended existing coverage. As a result, the number of municipality records in the database increased to 5,975, representing a total of 19,967 individual laws.



smokefree policies* for Publicly-Owned Multi-Unit Housing. *The majority of these are adopted by a Public Housing Agency to restrict or prohibit smoking in private units of the public housing properties it owns and manages.

cities and counties have enacted municipal laws that prohibit smoking in 100% of private units of rental multi-unit housing, and the laws in **75** of those communities prohibit smoking in 100% of private units of owner-occupied multi-unit housing.

We are the home of the only national database of smokefree and tobacco-free college campus policies.

colleges and universities are protected by smokefree policies, covering the entire campus, both indoors and out, 2,192 of them are completely tobaccofree, and **2,284** prohibit the use of e-cigarettes anywhere on campus. **1,247** also prohibit hookah use, and **643** prohibit smoking/vaping marijuana.



hospitals are protected by smokefree policies covering the entire campus, both indoors and out. In addition, 463 nursing facilities are protected by smokefree policies everywhere indoors.

NEW JERSEY TWO YEARS IN; STILL FIGHTING

Legislation to close the smoking loophole in NJ casinos is still an all-out brawl with the casino

industry refusing to go down, but more than 70% of lawmakers are co-sponsors. Casino industry lobbyists continue to submit a myriad of amendment proposals to leadership under the guise of compromise.



This campaign is generating a profound ripple effect across all gaming states. The outcome in New Jersey will be a significant part of our legacy.

ADVOCATE

The coalition, led by ANR/F and CEASE RI. continues to build legislative support and recruit bill co-sponsors. An advocate training was held in December 2023 to prepare for the start of legislative session 2024. Rumors are that House leadership may allow a vote in the new session starting in January. Passing the law in NJ will likely have a significant impact on the potential for advancement in RI.



KANSAS WORKER ADVOCATE LEADS THE WAY

A bill to advance smokefree casinos is a strong prospect for 2024. The key factor for KS is the amazing, relentless CEASE leader, Joe, who is a casino security officer. He has met with dozens of legislators and has promises from nearly 60 house members to support a smokefree casino bill. Joe also recruited many other casino workers to the cause from other segments of the industry.

SHAREHOLDER ENGAGEMENT

ANOTHER TOOL FOR POLICY CHANGE

In ANRF's first year of attempting to press for change from within the industry, we engaged with MGM, Caesar's Entertainment, and Boyd gaming. ANRF attended the Interfaith Center on Corporate Responsibility (ICCR) conference. Leaders from ICCR attended recent legislative hearings in PA and have engaged with lawmakers to express support for bill passage.

MEMPHIS TENNESSEE

SMOKEFREE 901 CAMPAIGN

The campaign kicked off Oct 30th with a coalition event led by faith leaders with support from ANRF, Shelby County Health Dept, The Center for Black Health and Equity, musicians, University of Memphis students, and other key health and community partners. In 2024, ANRF and The Center for Black Health and Equity will work to build and train advocates, engage policy champions, and work towards introduction of a local smokefree law.

TIPPING POINT STATE HEARINGS, G2E PANEL, SHAREHOLDER ADVOCACY

2023 was a year of firsts. The first smokefree hearings in New Jersey, Rhode Island, and Pennsylvania in more than a decade. The first opportunity to be part of a major gaming industry conference panel solely focused on smoking in casinos and going smokefree. Our first direct shareholder advocacy effort with casino companies. ANRF is at a tipping point in the smokefree movement.

CANNABIS/MARIJUANA TRACKING LEGALIZATION, DEFENDING CLEAN INDOOR AIR, EDUCATING ALL
