## Our vision.

### A Smokefree Generation

We want to protect the most vulnerable **among us from Big Tobacco's insistence** on profits over people. We envision raising a smokefree generation, free from addiction and health problems caused by tobacco.

The most vulnerable for secondhand smoke exposure are casino staff, bar and restaurant workers, and those in multi-unit housing where the landlord allows smoking. Over 40% of people in our country are not sufficiently protected from secondhand smoke.

## It is easier than you may think to include ANR in your will.

The following sample clauses may be helpful if you should choose to make a bequest.

### General Bequest:

### Bequest of a Residue:

"The rest, residue and remainder of my estate, both real and personal, wherever situated, I give and bequeath to Americans for Nonsmokers' Rights, located at 2530 San Pablo Avenue, Suite J, Berkeley, CA, 94702, to be used as the Board of Directors directs."
