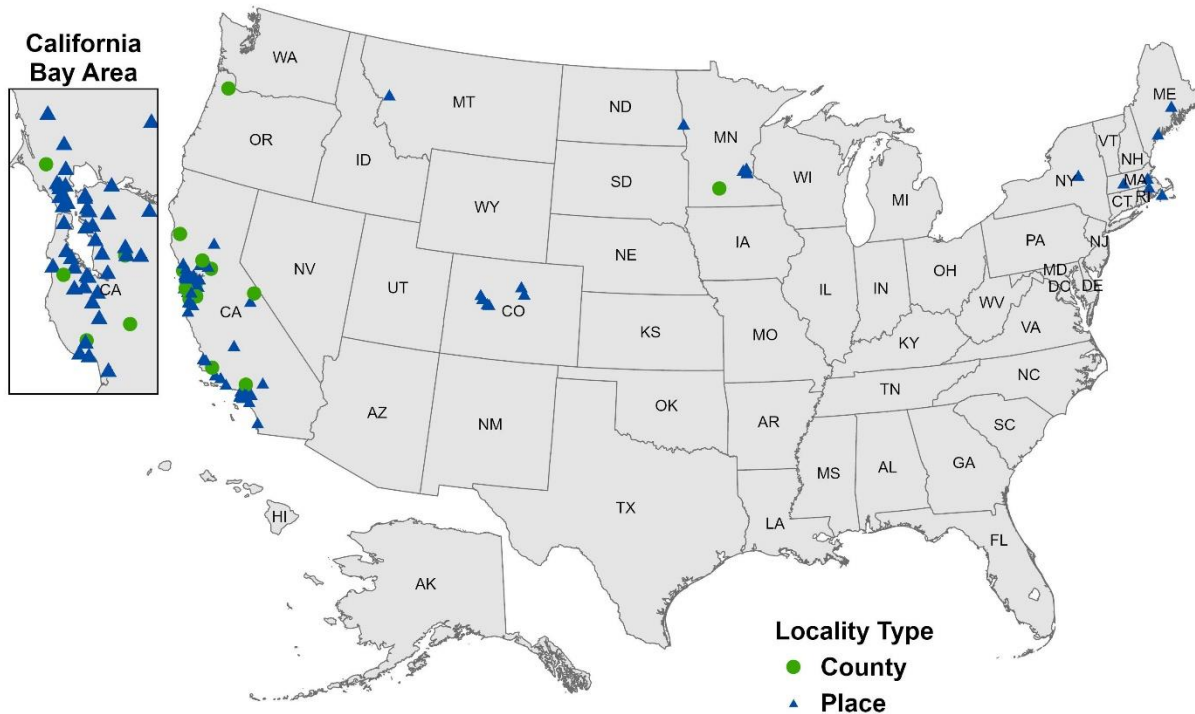


Municipalities Prohibiting the Sale of Flavored Tobacco Products

Enacted as of July 1, 2023

268 municipalities in total have enacted laws restricting flavored tobacco sales in some manner. Those listed below prohibit the sales of all flavored tobacco products, **including menthol**, without exception.

The map and list do not include municipalities whose laws contain exemptions, such as allowing sales in specialty retail stores or in certain buffer zones, or allowing the sale of menthol flavored products.
