

## Smoking Law Status in Major U.S. Travel Destinations

January 2, 2019

The following list provides the current status of the smoking laws with respect to restaurants, attached bars, freestanding bars, and hotel and motel rooms in more than 50 major business and vacation travel destinations in the United States. Those destinations in blue indicate that all restaurants, including attached bars, and all freestanding bars must be 100% smokefree. Call or write the local chamber of commerce or restaurant association to let them know either that you appreciate the location's smokefree law or that you are disappointed in the lack of a smokefree law. **Aspen, CO:** All restaurants and bars must be 100% smokefree. At least 75% of hotel and motel rooms must be nonsmoking.

Atlanta, GA: All restaurants and bars must be smokefree, unless they deny access to and do not employ minors. Smoking is also permitted in private separately ventilated rooms in restaurants and bars. At least 80% of hotel and motel rooms must be nonsmoking.

**Austin, TX:** All restaurants and bars must be 100% smokefree. At least 75% of hotel and motel rooms must be nonsmoking.

Bar Harbor, ME: All restaurants and bars must be 100% smokefree. No restrictions on hotel and motel rooms.

**Boston, MA:** All restaurants and bars must be 100% smokefree. 100% of hotel and motel rooms must be nonsmoking.

**Breckenridge, CO:** All restaurants and bars must be 100% smokefree. At least 75% of hotel and motel rooms must be nonsmoking.

**Burlington, VT:** All restaurants and bars must be 100% smokefree. 100% of hotel and motel rooms must be nonsmoking.

**Charleston, WV:** All restaurants and bars must be 100% smokefree. At least 75% of hotel and motel rooms must be nonsmoking.

**Chicago, IL:** All restaurants and bars must be 100% smokefree. At least 75% of hotel and motel rooms must be nonsmoking.

**Cincinnati, OH:** All restaurants and bars must be 100% smokefree. At least 80% of hotel and motel rooms must be nonsmoking.

**Cleveland, OH:** All restaurants and bars must be 100% smokefree. At least 80% of hotel and motel rooms must be nonsmoking.

Dallas, TX: All restaurants and bars must be 100% smokefree. No restrictions on hotel and motel rooms.

**Daytona Beach, FL:** All restaurants, including attached bars, must be 100% smokefree. Smoking is permitted in freestanding bars that earn less than 10% of their income from food. No restrictions on hotel and motel rooms.

**Denver, CO:** All restaurants and bars must be 100% smokefree. At least 75% of hotel and motel rooms must be nonsmoking.

**Ft Lauderdale, FL:** All restaurants, including attached bars, must be 100% smokefree. Smoking is permitted in freestanding bars that earn less than 10% of their income from food. No restrictions on hotel and motel rooms.

**The Hamptons, NY:** All restaurants and bars must be 100% smokefree. No restrictions on hotel and motel rooms.

**Hartford, CT:** All restaurants and bars must be 100% smokefree. At least 75% of hotel and motel rooms must be nonsmoking.

**Hawaii:** All restaurants and bars must be 100% smokefree. At least 80% of hotel and motel rooms must be nonsmoking.

**Helena, MT:** All restaurants and bars must be 100% smokefree. At least 65% of hotel and motel rooms must be nonsmoking.

**Houston, TX:** All restaurants and bars must be 100% smokefree. At least 65% of hotel and motel rooms must be nonsmoking.

**Las Vegas, NV:** All restaurants, including attached bars, must be 100% smokefree. Smoking is permitted in freestanding bars, provided they do not admit minors. No restrictions on hotel and motel rooms.

Lexington, KY: All restaurants and bars must be 100% smokefree. No restrictions on hotel and motel rooms.

Los Angeles, CA: All restaurants and bars must be 100% smokefree. At least 35% of hotel and motel rooms must be nonsmoking.

**Madison, WI:** All restaurants and bars must be 100% smokefree. 100% of hotel and motel rooms must be nonsmoking.

**Martha's Vineyard, MA:** All restaurants and bars must be 100% smokefree. No restrictions on hotel and motel rooms.

**Memphis, TN:** All restaurants and bars must be smokefree, unless they deny access to minors. At least 75% of hotel and motel rooms must be nonsmoking.

**Miami, FL:** All restaurants, including attached bars, must be 100% smokefree. Smoking is permitted in freestanding bars that earn less than 10% of their income from food. No restrictions on hotel and motel rooms.

**Milwaukee, WI:** All restaurants and bars must be 100% smokefree. 100% of hotel and motel rooms must be nonsmoking.

**Minneapolis, MN:** All restaurants and bars must be 100% smokefree. No restrictions on hotel and motel rooms.

**Monterey, CA:** All restaurants and bars must be 100% smokefree. At least 35% of hotel and motel rooms must be nonsmoking.

Nantucket, MA: All restaurants and bars must be 100% smokefree. No restrictions on hotel and motel rooms.

**New Orleans, LA:** All restaurants and bars must be 100% smokefree. 100% of hotel and motel rooms must be nonsmoking.

New York, NY: All restaurants and bars must be 100% smokefree. No restrictions on hotel and motel rooms.

**Northern Mariana Islands:** All restaurants must be smokefree except that smoking is permitted in attached bars after dinner service ends. No restrictions on freestanding bars. At least 80% of hotel and motel rooms must be nonsmoking.

**Orlando, FL:** All restaurants, including attached bars, must be 100% smokefree. Smoking is permitted in freestanding bars that earn less than 10% of their income from food. No restrictions on hotel and motel rooms.

**Philadelphia**, **PA:** All restaurants, including attached bars, must be 100% smokefree. Smoking is permitted in freestanding bars in existence as of 1/8/07 that earn less than 20% of their income from food. At least 75% of hotel and motel rooms must be nonsmoking.

**Phoenix, AZ:** All restaurants and bars must be 100% smokefree. At least 50% of hotel and motel rooms must be nonsmoking.

**Portland, OR:** All restaurants and bars must be 100% smokefree. At least 75% of hotel and motel rooms must be nonsmoking.

Puerto Rico: All restaurants and bars must be 100% smokefree. No restrictions on hotel and motel rooms.

Rapid City, SD: All restaurants and bars must be 100% smokefree. No restrictions on hotel and motel rooms.

**Rehoboth Beach, DE:** All restaurants and bars must be 100% smokefree. At least 75% of hotel and motel rooms must be nonsmoking.

**Reno, NV:** All restaurants, including attached bars, must be 100% smokefree. Smoking is permitted in freestanding bars, provided they do not admit minors. No restrictions on freestanding bars or hotel and motel rooms.

**Salt Lake City, UT:** All restaurants and bars must be 100% smokefree. No restrictions on hotel and motel rooms.

**San Diego, CA:** All restaurants and bars must be 100% smokefree. At least 35% of hotel and motel rooms must be nonsmoking.

**San Francisco, CA:** All restaurants and bars must be 100% smokefree. At least 35% of hotel and motel rooms must be nonsmoking.

Santa Barbara, CA: All restaurants and bars must be 100% smokefree. At least 35% of hotel and motel rooms must be nonsmoking.

Santa Fe, NM: All restaurants and bars must be 100% smokefree. At least 80% of hotel and motel rooms must be nonsmoking.

**Savannah, GA**: All restaurants and bars must be 100% smokefree. At least 80% of hotel and motel rooms must be nonsmoking.

**Seattle, WA:** All restaurants and bars must be 100% smokefree. At least 75% of hotel and motel rooms must be nonsmoking.

**Snowmass, CO:** All restaurants and bars must be 100% smokefree. At least 75% of hotel and motel rooms must be nonsmoking.

**St. Louis, MO:** All restaurants and bars must be 100% smokefree. At least 80% of hotel and motel rooms must be nonsmoking.

**Sun Valley, ID:** All restaurants, including attached bars, must be 100% smokefree. No restrictions on freestanding bars or hotel and motel rooms.

**Telluride, CO:** All restaurants and bars must be 100% smokefree. At least 75% of hotel and motel rooms must be nonsmoking.

Virgin Islands: All restaurants and bars must be 100% smokefree. No restrictions on hotel and motel rooms.

**Washington, D.C.:** All restaurants and bars must be 100% smokefree. No restrictions on hotel and motel rooms.

## The following 33 state or commonwealth/territory laws are of particular significance:

Arizona, California, Colorado, Connecticut, Delaware, Guam, Hawaii, Illinois, Iowa, Kansas, Maine, Maryland, Massachusetts, Michigan, Minnesota, Montana, Nebraska, New Hampshire, New Jersey, New Mexico, New York, North Carolina, North Dakota, Ohio, Oregon, Puerto Rico, Rhode Island, South Dakota, U.S. Virgin Islands, Utah, Vermont, Washington, and Wisconsin require all restaurants and bars to be 100% smokefree.

**State or commonwealth/territory laws** in American Samoa, Florida, Idaho, Indiana, Louisiana, and Nevada require all restaurants, but not all bars, to be 100% smokefree.

The following **state or commonwealth/territory laws** require that at least a specified percentage of hotel and motel rooms be smokefree:

Arizona (50%), Arkansas (in places with more than 25 units, 80%), California (80%), Colorado (75%), Connecticut (75%), Delaware (75%), Georgia (80%), Hawaii (80%), Illinois (75%), Indiana (100%), Iowa (80%), Kansas (80%), Louisiana (50%, except for hotels operated by casino and gaming operations), Maryland (75%), Michigan (100%), Montana (65%), Nebraska (80%), New Jersey (80%), New Mexico (75%), North Carolina (80%), North Dakota (100%), Northern Mariana Islands (70%), Ohio (80%), Oklahoma (75%), Oregon (75%), Pennsylvania (75%), Rhode Island (50%), Tennessee (75%), Vermont (100%), Washington (75%), and Wisconsin (100%).

## Although many travel destinations still have weak smoking control laws, there is a growing national trend toward 100% smokefree laws for both restaurants and bars.
